Property tax relief, prisons and water policy top governor's priority list

ov. Pete Ricketts revealed his upcoming budgetary and legislative priorities in his State of the State address to lawmakers Jan. 13. Top priorities outlined by the governor include property tax relief, construction of a new state penitentiary and a new water reservoir system.

"Through the years, the guiding light of my administration has remained the same: to grow Nebraska," Ricketts said. "And, despite weathering floods, fires and a global pandemic, we have done just that."

By the end of fiscal year 2023, he said, Nebraska is anticipated to have an estimated \$1.5 billion in its Cash Reserve Fund.

"This is the people's money, and we must support tax relief that puts

Tax credit scholarship proposal stalls on first round

enators rejected a second attempt to advance a bill from general file that would create a tax credit scholarship program for Nebraska private school students after a failed cloture motion Jan. 12.

LB364, introduced by Elkhorn Sen. Lou Ann Linehan, fell four votes short of a successful first-round cloture motion last session. It returned to the agenda this year after Linehan designated it as her priority bill for the 2022 session.

She said the proposal would give up to 1,500 children the opportunity to attend a private school that better meets their needs, a choice not available to many low-income Nebraska families.

"If you can afford it, you have [school] choice," Linehan said. "But if you can't, you do not."

The bill would allow individuals, passthrough entities,

estates, trusts and corporations to claim a nonrefundable income tax credit of up to 50 percent of their state income tax liability on contributions they make to nonprofit organizations that grant scholarships to students to attend private school.

Only Nebraska residents would be eligible for the scholarships, which could be used to pay tuition and fees at a qualifying privately operated elementary or secondary school in Nebraska.

Students would be eligible for the scholarships if, among other requirements, they are a dependent member of a household with a gross income that does not exceed the eligibility guidelines for reduced-price meals under the National School Lunch Program.

As introduced, LB364 would allow the state Depart-

this money back into the pockets of the people," Ricketts said.

Accelerating the phase-in of Social Security tax exemptions to five years, instead of the current ten-year period, would allow older Nebraskans to keep more of their hard-earned money, he said. Additionally, Ricketts said, the state individual tax rate should be reduced by one percent over the next five years.

Citing public safety concerns, the governor proposed spending \$16.9 million to enhance the state crime lab and an additional \$47.7 million toward expansion of the Law Enforcement Training Center in Grand Island, in addition to funding a new state penitentiary.

"The existing state penitentiary was built over 150 years ago. Its walls are crumbling and its infrastructure has aged beyond simple repair. A modern facility will give our inmates a better quality of life," Ricketts said.

The governor also recommended \$500 million be spent on construc-

tion of a canal and reservoir system from the South Platte River to protect quality drinking water, keep electric generating costs manageable and ensure farm and ranch production.

"If we fail to secure our supply from the South Platte River, we could expect to lose 90 percent of the water that currently comes to us from Colorado," he said. "We must act to preserve, protect, manage and steward our water supply for our future Nebraskans."

Ricketts' proposed budget also includes an additional \$200 million for water projects presented by the Statewide Tourism and Recreational Water Access and Resource Sustainability Committee, also known as STAR WARS, which he said would secure access to water and advance state tourism.

Finally, the governor proposed a number of one-time initiatives for allocating Nebraska's \$1.04 billion share of federal coronavirus relief funds from the American Rescue Plan Act. Among his priorities are securing funds for low-income children who

have experienced learning loss due to the pandemic and funding behavioral health and nursing incentives.

"I look forward to the challenge, opportunity and honor of working with you," Ricketts said. "Remember, Nebraska is what America is supposed to be."

ment of Revenue to grant \$10 million in credits in 2022. After that, if at least 90 percent of the credits in any given year are claimed, the annual limit would increase by 25 percent.

A pending Revenue Committee amendment instead would limit the total amount of credits available each year to \$5 million and omit the mechanism allowing credits to increase each year.

The amendment also includes the amended provisions of LB531, introduced by Albion Sen. Tom Briese.

Under his proposal, taxpayers who make a qualifying financial contribution to certain child care and early childhood education programs in Nebraska could apply for a nonrefundable income tax credit equal to a portion of the contribution.

Sen. Justin Wayne of Omaha supported LB364, saying the achievement gap for Black students in the Omaha Public Schools district persists despite increases in school funding.

"We can't keep doing what we're currently doing," he said. "Let's try something else."

A pending Wayne amendment would end the credits after 10 years, which he said is enough time to determine whether the scholarships have a positive effect on students who receive them.

Omaha Sen. Terrell McKinney said he had changed his mind about LB364 since last year and now supports it. He said private schools could offer an alternative to North Omaha public schools that are failing some students.

Sen. Megan Hunt of Omaha opposed the bill, saying it would not address problems, including poverty

and housing insecurity, that lead to the achievement gap.

She said the proposal would use public funds to indirectly benefit private schools that are allowed to discriminate against students and teachers based on their gender identity, sexual orientation and other factors.

Hunt introduced an amendment last session that would prohibit a scholarship granting organization from discriminating against students on the basis of race, color, religion, national origin, ancestry, citizenship status, gender, sexual orientation, gender identity, disability or special education status. It failed Jan. 12 on a vote of 17-26.

Sen. Adam Morfeld of Lincoln also opposed LB364, saying it would divert state tax dollars that could be used to improve underperforming public schools.

He offered an amendment that would require schools that enroll students who receive tax credit scholarships to comply with the same budgetary requirements that apply to public school districts.

"If we're going to be providing ... this type of incentive," Morfeld said, "then these institutions should have to play by the same rules and have the same level of transparency as any other institution that receives this type of public benefit."

Several senators questioned why the proposed credit should provide donors a greater, dollar-for-dollar tax benefit than other charitable donations, which qualify for a tax deduction that is calculated using a donor's income tax rate.

After eight hours of debate on general file, Linehan filed a motion to invoke cloture, which would end debate and force a vote on LB364 and any pending amendments.

The motion failed on a vote of 28-14. Thirty-three votes were needed. A failed cloture motion results in debate on a proposal ceasing for the day. The bill is unlikely to be placed on the agenda again this session.

Convention of the states effort advances

A resolution to authorize Nebraska to participate in a convention of the states advanced from general file Jan. 10.

LR14, introduced by Hastings Sen.

Steve Halloran, would be Nebraska's application for a convention of the states authorized under the U.S. Constitution. If 34 states commit

to a convention, states could propose amendments to the U.S. Constitution that would limit the size and authority of the federal government, consider fiscal restraints and consider term limits for members of Congress.

Halloran said 15 state legislatures have called for such a convention. He said the nation's nearly \$30 trillion debt is evidence that the federal government is acting irresponsibly.

"The federal government needs an intervention," Halloran said. "The federal debt is spiraling out of control. America is now reaching a tipping point."

Albion Sen. Tom Briese supported the resolution, saying he favors constraints on federal spending and term limits for members of Congress.

"If you believe as I do, you have to ask yourself, how else are you going to get this done?" he said.

Lincoln Sen. Adam Morfeld said the resolution could lead to a "runaway convention" that could go beyond LR14's intended scope. He added that a group met in America's infancy to revise the Articles of Confederation, but instead scrapped them entirely and adopted the U.S. Constitution.

"The only precedent we have, colleagues, is our current constitution, which went far outside the bounds of the original call," Morfeld said.

Sen. Carol Blood of Bellevue also opposed LR14. She said several states have rescinded their applications for a convention of the states in recent years.

"Our constitution is not the problem," she said. "The problem is big money in campaigns."

Morfeld offered an amendment that would prohibit a convention of the states from proposing any amendments to restrict, disempower or eliminate gun rights guaranteed by the Second Amendment of the U.S. Constitution.

Halloran called the amendment a "poison pill," because all state applications must be identical, and urged senators to vote against it.

The Morfeld amendment failed on a vote of 12-22. LR14 then advanced to select file on a 32-10 vote.



Bill to cut inheritance tax rates, increase exemptions advanced

Lawmakers gave first-round approval Jan. 11 to a bill that would cut Nebraska's inheritance tax rates while increasing the amount of property

value that is exempt from the tax.

As introduced by Elmwood Sen. Robert Clements last session, LB310 would have cut rates in half over

three years while increasing the exempted amounts.

Clements said Nebraska is one of only six states with an inheritance tax, making it a "bad place to die." LB310 would drive economic growth by keeping more retirees in the state, he said.

Clements said the inheritance tax, which in Nebraska is collected by counties, can seem "arbitrary and excessive" and that heirs sometimes must sell part of their inheritance to pay the taxes owed.

"I think we can do better as a state than to treat families this way," he said.

A Revenue Committee amendment, adopted 40-4, replaced the bill. Under the amendment, immediate relatives would pay inheritance tax on the clear market value of property over \$100,000 received by each person, up from \$40,000. The tax rate would remain 1 percent.

The amendment also would decrease the rate from 13 to 11 percent for remote relatives and increase the exemption from amounts more than \$15,000 to amounts over \$40,000.

A third rate, currently 18 percent of the clear market value of beneficial interests over \$10,000, applies in all other cases. The amendment would reduce the rate to 15 percent and increase the exemption to amounts more than \$25,000.

Under the amendment, any interest in property passing to beneficiaries younger than 22 would not be subject to inheritance tax.

The changes would apply to estates of individuals who die on or after Jan. 1, 2022.

Clements said the amendment would reduce inheritance tax collections by 15 percent, compared to 50 percent in his original proposal.

Sen. Lou Ann Linehan of Elkhorn supported the amendment, saying it would make reasonable adjustments to a "very unfair and very regressive" tax that, at current exemption amounts, affects Nebraskans who inherit only modest assets.

Thurston Sen. Joni Albrecht also supported the proposal. She said counties could use a portion of the \$375 million in federal coronavirus relief funding they are slated to receive this year to offset lost inheritance tax revenue, which totaled approximately \$63 million in 2020, according to a Platte Institute study.

Albrecht said Iowa passed a bill last year phasing out its inheritance tax over four years, which will make

Nebraska the only state west of the Mississippi River with an inheritance tax. She introduced but later withdrew an amendment that would have eliminated Nebraska's inheritance tax by 2028.

Sen. Steve Erdman of Bayard supported Albrecht's amendment, saying county boards would be able to budget for the gradual phasing out of inheritance tax revenue. He said the inheritance tax is a "double" tax because decedents already have paid property taxes on the homes and other real property that they pass to their heirs.

Sen. Matt Williams of Gothenburg opposed Albrecht's amendment. He said American Rescue Plan Act funds must be spent by 2026, which means they could not offset lost inheritance tax revenue over the long term.

Adams Sen. Myron Dorn opposed the committee amendment and the bill. He said many counties would raise property taxes — their only other major revenue source — to pay for county services if the inheritance tax is reduced or eliminated.

Senators voted 41-4 to advance LB310 to select file. ■


