Legislature convenes, elects Executive Board chair

enators returned to the State Capitol Jan. 3 to begin the second session of the 108th Nebraska Legislature.

La Vista Sen. John Arch, Speaker of the Legislature, welcomed senators back and urged them to focus on strengthening the institution and enacting policies that will benefit everyone in the state.

"Let's work hard, build relationships and show respect for each other as we build a better Nebraska over the next 60 days," Arch said.

Lawmakers elected Grand Island Sen. Raymond Aguilar over Omaha

Sen. Machaela Cavanaugh as chairperson of the Executive Board, which oversees legislative services and employees. The vacancy was created when former Sen. Tom Briese left the Legislature in November to become state treasurer.

As vice chairperson, Aguilar had served as acting chairperson of the Executive Board since Briese's resignation. Kearney Sen. John Lowe was chosen as the new vice chairperson, fending off a challenge from Omaha Sen. Terrell McKinney.

Property tax reform and workforce development likely will be top priorities for lawmakers this session. Senators also may consider changes to the duties of the inspectors general for the state's prison and child welfare systems, following an attorney general's opinion that questioned the constitutionality of those offices.

New bills will be introduced for the first 10 days of the session, or until Jan. 17.

Before addressing any new measures, however, lawmakers will consider a number of proposed changes to the Legislature's permanent rules. The rules debate is expected to begin Jan. 10.

Gov. Jim Pillen will give his State of the State address Jan. 18, followed Jan. 25 by Nebraska Supreme Court Chief Justice Michael Heavican's State of the Judiciary address.

Committee hearings are set to begin Jan. 22 and continue through Feb. 29.

Meyer will complete the final year

of the term left vacant by the resignation of former Sen. Tom Briese of Albion last month. Briese resigned his seat after being appointed by Gov.

The governor announced Meyer's appointment at a press conference, noting that there were 16 applicants for the position. Pillen cited Meyer's long history of public service as one reason for choosing him.

Meyer, who served for more than a decade on the Nebraska State Board of Education, described himself as "truly humbled" to be asked to serve.

"I'm anxious to get started in the Legislature," he said. "I have a lot to learn."

A native of West Point, Meyer is a graduate of the University of Nebraska-Lincoln and has been active in numerous community and agricultural organizations. He and his wife, Kay, have been married for 46 years and have three sons.

Meyer was sworn in by Nebraska Secretary of State Robert Evnen. His term began immediately and will end in January 2025. Meyer indicated that he will not seek election to the Legislative District 41 seat in the 2024 general election.
